DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Caldwell-Vaughan house is the three northern bays of a five bay dwelling, constructed in the 1870's. It is two storys tall with a four bay long wing on the west side being original and part of the 1870's dwelling.

Across the entire facade is a one story screened porch divided according to ownership. It has outstanding original detail on its square chamfered posts with applied decorative panels on the base to brackets extending up the facade of the posts to the cornice. Along the cornice is a series of modillions, and beneath the facia is a pierced bracketed gallery extending between the posts. The balustrade is low and follows the division of the porch. It probably replaces an earlier pierced balustrade which was removed in the 1920's.

On both storys the sash have 4/4 panes and there is a small cornice-like decorative motif above the windows. The central door possesses a similar cornice, though larger in scale. Glass panels in the principal door appear to be later alterations. Above the second story windows are pairs of brackets in the facia. One gutter box remains on the north side. On the gable end are pairs of windows with a small casement in the attic. The 'A' roof is covered with green asphalt.

STATEMENT OF SIGNIFICANCE

Architecturally the building is of note only for its contribution to the rhythm of the streetscape, but as an interesting example of a vernacular form with Italianate detail.

It is also important as the former residence of John M. Reed who operated a store on the corner of Bohemia Avenue and First Street.







 Sanborn Map, 1933, Sheet 4


