DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Few buildings on Bohemia Avenue possess gables attached to their facades. One other building located adjacent Mrs. Benson's house has such a Victorian feature. The facade of Caldwell house is very similar to the Kinter Tenement, but there is a bay window on the north gable and the one story porch follows the configuration of the facade and bay window, creating a semi-octagonal screened porch. There is lattice between brick piers and the columns supporting the roof are round. Between the columns are runs of turned balustrade. The facade is three bays wide with entrance on the northermost bay. All walls are covered with white aluminum siding and the windows have 1/1 sash and white trim. As mentioned above, there is a gable in the center of the green asphalt shingle roof. On the west side of the structure is a long two story wing, two bays having the ridge running east-west and the end having the ridge running north-south.

The house stands in a good size yard and has many fine trees and shrubbery.

Behind the dwelling is a modern two car garage covered with aluminum siding, opening onto Fourth Street.

STATEMENT OF SIGNIFICANCE

Caldwell's House is architecturally of interest due to the fact that it has basically an earlier form, but its gable on the facade gives it a Victorian Gothic element and the porch reflects the taste of the Queen Anne's style. It is scaled favorably with its neighbor to the north and is a good transitional building for the corner of the street, because it has an interesting side view which is due to subsequent additions. The specimen trees are also very important to the appearance of the south end of Bohemia Avenue.

The father of the present owner of the house, Hugh W. Caldwell, Sr., holds an important place in the development of the Cecil County educational system. Hugh W. Caldwell, Sr., was Superintendent of Schools for Cecil County, holding that position until his death in 1926. Hugh Caldwell, Sr. came to Chesapeake City in 1898 having been educated at Jacob Tome Institute in Port Deposit, Maryland. He served as a teacher and later as principal, in 1901, of the newly established high school in Chesapeake City. At this time, one room of the six room building on West Third Street was set aside for the high school students. Mr. Caldwell conducted his classes in one end of the room; his assistant, Miss Alice Perry, used the other end. There were twenty-six high school students in 1901; four in that year's graduating class.

Until this time, students going on to college or preparing for a profession, went to a private school. Naturally, this higher education was welcomed by the community.

Mr. Caldwell bought this house in 1916 for \$2,100.00 from Lillie K. Barwick and her husband Oakley. It has always been used as a private residence since the builder, Richard B. Stubbs, occupied the house in 1874.






