DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Parish House was built for the parish in the 1920's. It is a large one story stuccoed frame building with irregular fenestration. The gable faces the street and has a central double door with 'A' roof hood above supported on plain brackets. Two eight pane casement wondows flank the entrance. There is a louver in the gable and a wooden cross at the apex of the roof.

A small chimney rises from the northwest corner of the structure as well as the south east corner. A fireplace is built about centered on the south wall. Flanking the fireplace are two eight pane casements, and a series of three casements. A single casement is located on the eastern end of the south side.

The roof is an 'A' roof covered with green asphalt shingles. At the eave, the rafters extend and are un-shaped.

Around the south yard is an oak fence composed of a 1 x 6 at top and bottom and two 1 x 4 which cross between posts.

Between the church and hall, at the west fronts of the building is a retaining wall.

STATEMENT OF SIGNIFICANCE

The architecture of the Parish House indicates the growth of the community and interest in social gatherings when things on the Canal were at a slower pace than before.

It is a very simple structure which has served the purposes for which it was constructed.

This Parish House was built in the 1920's largely through the efforts of James Adams. Mr. Adams was the owner of a showboat that plied the Chesapeake Bay giving a different show each night for the week spent at each stop. Members of his family made up part of the cast and they were a popular attraction on the Bay for many years. The showboat tied up at the foot of Bohemia Avenue, behind the warehouses. After many years of service, the showboat met with disaster and Mr. Adams brought his family to live in Chesapeake City.

When the building was new, it boasted a stage and dressing rooms to accommodate amateur theatricals, which were very popular in the 1920's. By 1940, the ladies of the church felt the need for a kitchen and had the stage converted into a cooking and serving area. Many public meetings and banquets have taken place in the church hall which is made available for community use.




