 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The second house on the right approaching Chesapeake City from the south is a four bay long, four bay deep, two story structure which has recently had a facelift. The walls are covered with tan aluminum siding and the windows have 1/1 sash with white trim. Its roof is covered with raised seam tin painted black and a small chimney rises from the center of the 'A' roof.

On the back of the building is a leanto which is a continuation of a kick in the rear slope of the roof. It is in very good condition, however, it lacks the character typical of the old dwellings in the district.

It is unusual for its form. It resembles the Pastor house in the first block of Bohemia Avenue, and the Elkins-Conrey Duplex in the next block.

STATEMENT OF SIGNIFICANCE

This dwelling was probably constructed as a duplex, similar to the Elkins-Conrey Duplex in the next block of George Street. Any detail which this dwelling had originally, has been removed. It is typical of the plainer sort of rental property in Chesapeake City.

This house was probably built about 1909, by Byron Bouchelle, a storekeeper on Bohemia Avenue. No doubt it was originally an investment property then as it is today. At one time one of the occupants had a small machine shop in an outbuilding facing on the alley. For many years the house was owned by William Metz and his heirs.




