DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The facade of this building has been totally remodeled with board and batten and new windows and door. The building appears to be constructed upon a brick foundation. Its walls, other than the above mentioned facade are covered with weatherboard and painted dark brown. The 'A' roof is covered with corrugated tin painted aluminum.

Behind the main block is a one story addition which can barely be seen from the street.

The door is located on the north side of the facade with a nearly square 6/6 pane sash window. The second story windows have two pane sliding glass windows. All possess white aluminum shutters.

Along the street is a section of brick paving and a brick step to the door.

STATEMENT OF SIGNIFICANCE

Richard H. Bryan, a merchant, and Elize, his wife, were deeded this property in 1854 by Richard H. Bayard and Mary Sophia. They in turn sold it for two hundred dollars to John J. Burbaze, in 1855. This deed mentions buildings and probably refers to the house now on the lot.

At one time the Toy family lived here. They were a family of fishermen who netted carp in the rivers and kept them in a pond outside of town to fill orders from city fish markets.

The house has no significance other than being a typical home for working people, and maintaining the rhythm of the structures along George Street.






