DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The smallest house on this block of George Street is this one bay, two story frame building, with one bay, one story extension. It is built very close to the ground and is covered with tan asphalt ersatz brick. The chanel drain tin roof is lower than the neighbor to the south.

Its facade has a door on the north side with a nine-pane sash adjoining. On the second story is a small window with 3/6 sash. Above the door is a crude small 'A' roof hood. On the south gable is one window on the first story with 2/2 sash and on the second an original 6/6 sash. The front window is probably at floor level.

Half of the extension protrudes from the south wall half its width. An entrance with shed hood is located on its east facade.

A short section of picket fence exists between the house and adjoining vacant lot.

This little building probably had a 6/6 sash window on the first story, weatherboard siding and a wood shingle roof. With these few elements restored, it would be more picturesque than it is at present. For a more liveable arrangement, however, it would be ideal for the adjoining lot to be acquired and a modern section built with this house as part thereof.

STATEMENT OF SIGNIFICANCE

Even with its great alterations over the year, this dwelling retains the individuality which it once had. It is now the smallest dwelling in town and offers an interesting and subtle variation to George Street.

This small tenant house was probably built about 1854, by William H. Loudon. The clapboards were probably whitewashed. Two lime kilns were near the town, one to the south and one east, and they used the mountains of oyster shells brought in by watermen to make lime. This home is significant only in that it's an example of the housing provided the watermen of the period.






