STATEMENT OF SIGNIFICANCE

In the early days of Chesapeake City fire was a dreaded thing. The only defense was a bucket brigade and that was usually too little too late. In 1911, a fire on Canal Street on the north side of the Canal destroyed three buildings and would have spread farther if a steamer passing through the Canal had not turned its hoses on the blaze. This event moved the townspeople to action and a fire company was organized. The original frame fire house is now in use as a town office on the north side of town.

The organizing meeting took place over Reed's Store, in March of 1911.

The house on this lot was destroyed by fire and eventually cleared away.






