DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The last house north on Pine Street, with its side overlooking the Canal is a small two bay wide, two story frame building with one story wing on the west and a leanto on the east street facade.

The entire structure is covered with white aluminum siding in contrast to the black aluminum shutters, which are too large for the windows. The roof is a grey-green asphalt shingle covering except the slate grey of the porch. The windows appear to retain original 6/6 sash. In the north gable is a brick chimney rising from the apex of the low pitched 'A' roof. Flanking the chimney on the first story are port hole windows which appear to date from the recent remodeling.

It is a shame the effort and money expended on the remodeling was not directed to a more authentic type of remodeling. With wood weatherboard and suitable size windows it could have been a good example for the rest of the community.

STATEMENT OF SIGNIFICANCE

Architecturally, this building has little significance, especially with the recent renovations which covered all but the form of the structure. As a dwelling for a school teacher, it is significant, however.

This small house has had a ringside seat for activities on the Canal since before 1878, it being one of the houses indicated on Lake's map. For many years, the house was owned by the Nowland family.

Lambert D. Nowland was a local school teacher in 1850; his son, Edward, a medical student. The house has no special significance.







 Sanborn Map 1933, Sheet 4




