DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a stone farmhouse two stories in height. It is rectangularly shaped five bays long by two deep. The western most section of the house is a later addition as is the rear wing. The original house was three bays long by two deep with an inside end chimney in each gable wall. The stone is covered with stucco and whitewash. The house has a gable roof with a metal covering. The window sash has been replaced in some of the windows but there are still some sash with six panes. The house faces south with a central bay entrance.

During the 19th century a two bay by two addition was built on the west gable of the original house and a kitchen wing was built behind this addition. The house has the look of a late 18th century farmhouse perhaps early 19th.
