This log ruin consists of a stone foundation and hand dug cellar. Only portions of the north, south and west walls remain. The logs were laid in the saddle notch method and were chinked with mud. There was a stone chimney and cooking fireplace in the east gable end. The logs were covered with hand split lath on the interior. The exterior had crude clapboard siding with tarpaper over it. The height of the structure was one story with an attic.
