DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This bridge is located on the Little Elk Creek. It was built in 1903 by the York Bridge Company of York, Pennsylvania. It is built of steel and rests on stone supports on the banks of the streams. The frame is riveted together and has a wooden bed. The foundations at either side of the creek resemble those of covered bridges and there very well could have been one on this site. The bridge is approximately 56 feet long.
