The Fagan House is a two-story frame building two bays long by three bays deep. There is a brick inside end chimney on the east wall. The house has recently been covered with aluminum siding. The sash is six over six. To the rear of the center portion is a two-story addition. The house was built on a stone foundation. The facade has a front porch that was added in the past ten years.

This house is very plain in appearance and perhaps could have served as a warehouse. To the rear of the property is a small non-descript outbuilding.
