DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a two story frame house with an inside end chimney in the south gable end. The house has a stone foundation and there is a one story addition to the north of the earlier home. It also has a chimney in the south gable end. The roof of the addition is much steeper

The original dwelling measures two bay by two bays. The lath under the clapboard has circular saw marks. The window frames are plain and the windows have six panes over six panes. The door frames are pegged. The roof originally was wood shingle, but is now asphalt.

Both parts of this dwelling have a one story front porch running the entire length of the facade. The earliest section dates from a 1850-60 period while the addition was circa 1900.
