DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Edwin A. Smith House is a two-story frame house four bays long by two bays deep. The exterior is covered with clapboard, some is newer on the facade and is beaded. There are two inside end chimneys made of brick, the eastern most is much wider. The house rests on a stone foundation with a full basement. The floor joists are hewn and support wide flooring. A one-story porch has been built on the west, east and south walls of the house. It has a cedar shake roof and is supported by chamfered posts. The roof is of gable construction with a box cornice. It is shingled with asbestos shingles. There are two small windows in the west gable end in the attic story. Rest of windows are 2/2.

There are several small outbuildings and a rather large barn.
