DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house appears to have been built at several different times. The western most section has a gable roof with an interior chimney. It is a two-story frame home with clapboard siding. This section is two bays by two bays. The windows have two panes oder two panes with louvered shutters. It has a basement with stone foundation. Butted up against this section is another frame building with a lower pitched roof with a brick fireplace in the north east corner. It is two bays wide by three deep. Connected to the eastern wall is a two-and-a-half story tower which sits against a wing that extends to the south of the section. The roof covering varies from tin to wood shingle. A porch one-story in height is found on the east and north sides of this dwelling. A lean-to kitchen has been built off the wing and tower.

There are several outbuildings and a small barn. One of the outbuildings is stone and could be earlier than the others.
