DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Phillips House is a frame farmhouse 2 and ½ stories in height. It is three bays long by two wide with a small rear wing. There is a basement with stone walls. The floor joists are hewn and mortice and tenoned. The floor is pine. There is an inside end chimney at each gable end. The exterior is covered with clapboard and asbestos shingles. The window sash is six panes over six through out.

There is a central hall with room to either side. The stairway to the second floor is located in this hall. It is open string with newel. The front door has a transom with sidelights. In the front rooms some chairrail remains.

The rear wing is one and a half stories in height with an inside end chimney. There were bars in the second floor windows. The very thick walls could have been built of logs. The fireplace was a walkin, but has been changed.

A small circa 1900 barn and windmill are on the property.
