DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This home was built in two separate time periods. The western end of the house is a Greek Revival two and a half story structure. It is frame with clapboard siding. This section is three bays long by two deep. There is an inside end chimney built of brick at each gable end. The front door has a transom with sidelights. The foundation is part stone and part brick. The window sash is six panes over six throughout. The windows have paneled shutters. The front door has a single bay Victorian hood. On the interior there is a central hallway with a winding open string stairway. The mantel is plain with a keystone with a panel to each side. To the left of the eastern fireplace is a wall cupboard with paneled doors. The roof has a low pitch and is tin.

The other section of the house is connected to the eastern wall of the Greek Revival structure. It is built of log on the first story and has a frame second story. It has a small steep stairway. A shed extension has been built off of this structure. A porch runs the entire length of the south wall.
