This building is a double house four bays by two two stories in height. It is of frame construction with red shingles covering the original clapboard. There is a one-story front porch four bays long. The roof is of low pitch and the two roofs are ever so slightly different. The sheet metal roofing makes the difference known but barely. On the rear is a leanto addition. In the rear halves of both sides is an interior chimney. Some of the window sash is six over six while other is newer single pane.
