DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Dayid Mackie Farmhouse is a two-story frame structure located one quarter mile off of the old Christeen Road. It is five bays long by two deep with a two-story rear window which appears to be of later date. The house has clapboard siding and an inside end chimney at each gable end. The roof is gable with a box cornice and crown molding. The roof rafters are pinned and numbered with Roman numerals. The flooring is tongue and groove.

The lathe is hand-hewn; a small winding stairway connects each floor. The downstairs floorplan consisted of a central hall with a large room to each side. There was chair rail throughout the first floor. Under each window is molding that matches wood work on the mantel. The mantel has fluted columns that use form stops at the floor. It is original. A peaked dormer has been added to the center of the attic story. The house has a full cellar with chimney supports. The floor joists are of log and are bark covered. Several early 19th century thumbblatches can be found on the first floor.
