DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Layman Log House is four bays by two and is one-half log and one-half frame. The house is two-stories in height with a steep roof. The western half of the structure is log laid in saddle notch style. The roof is covered with corrugated metal with wooden shingles underneath. Beneath the roof is a simple box cornice. The exterior of the building has white tile shingles on it. On the south side of the house is a one-story frame lean-to addition. The facade has two doors, one for each side. The rafters are pinned and the logs are visible in the attic. Between the two sections is a brick chimney. This chimney goes with the log side of the house.

A small barn is located to the east of the house. It has a stone foundation and is of mortice and tenon construction. It has a sal box line to it.
