DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The T. Brown Road House is five bays long by two deep. It is two stories in height with a one-story lean-to addition extending from the rear of the building. At least one half of this structure is frame; the other could be log. The exterior is covered by tarpaper with white tile shingles over the paper. There is an interior chimney that has a "durch oven" at its base. The east end of the house appears to be the oldest; it is two bays by two. The facade has a front porch and two front doors. The sash is 6/6. This building is almost identical to the Layman Log House.

The stone foundations of an old barn stand to the east of the house with two early 20th century buildings in between (outbuildings).
