DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Hickman House is a two story double house built of brick. It is four bays long by two bays deep with an inside end chimney in each gable wall. The sash on the first floor are six over six while those on the upper floor have been replaced with storm windows. The exterior of the building is covered with stucco. The roof is gable with a simple box cornice. A one story porch with vernacular Victorian supports runs the entire length of the facade.
