**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Levi Kirk House was built in 1835 as a date plaque in the central bay of the facade indicates. The house is L-shaped and the rear wing could have been an earlier structure. The entire home is built of brick and is covered with stucco. The majority of the brick work is laid in American bond with the gable end of the rear wing being of Flemish bond. The front section is five bays long and two bays deep while the rear section is three by two. The 1835 portion of this dwelling is two-and-a-half stories in height and has a slate shingled roof with plain box cornice. Protruding from the roof are three gabled dormers which face to the south. The central door has a transom and side lights. The window sash is 9/6 on the 1835 part and 8/8 on the earlier wing. Originally the sash was 9/6. The rear section has a wide chimney in the gable wall while the front has an inside end chimney in the east gable and an exterior end chimney in the west. The walls are 18" thick and a one story front porch runs the length of the facade.
