DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The College Green Brick House is a two story L-shaped brick dwelling that is situated across the road from the Beard House of 1740. It is four bays by two. The facade of the building is American bond, but the south gable wall and wing are Flemish bond. There are two chimneys, one is in the north gable of the front section and the other is an interior chimney in the wing. There is a shed (made of Brick) addition on the rear wall of the front part of the structure. The facade has double entrances, one has a transom. The entrance on the rear wing, also, has a transom. The roof has roof shingles and box cornice. The window sash is six over six. The house has a stone foundation.
