**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Miller Farmhouse is T-shaped and constructed of brick. The brick is laid in running bond and covered with a layer of fake white bricks. This house has a peaked dormer over the central bay in the front section. The main part of this home is three bays by two with a rear wing which is two bays by two. The rear wing has an inside end chimney while a small brick stove chimney is located in the north east corner of the front section. The roof is covered with slate and has a box cornice with crown molding. The window sash is 2/2 with one window 4/4. The facade has a central front door that has a transom with sidelights. Also on the front of this house is a one-story front porch of Victorian vintage.
