DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The McMillian Kirk House is a massive dwelling built of brick laid in common bond. The house was built around 1800 and is typical of several other structures in Calvert. The house is rectangularly shaped three bays long by two deep. It is two stories in height with an attic. In the north gable wall is an end chimney that services fireplaces on the first and second stories. The entrance is located on the right side of the facade and enters onto a hall and rounded stair. To the left of the hall are two large rooms with federal period stepped mantels and chairrail. The second floor has a similar floor plan.

The window sash is 9/6 on the first floor and 6/6 on the second floor. During the late 19th century a large two story frame addition was built on the rear of the house. The gable roof was extended and this gave the house a "catslide roof". The exterior of this building was covered with white tile brick which has ruined to some degree. The house has a stone foundation with cellar. On the property are several outbuildings. Most are early twentieth century with the exception of one small barn.
