The Crother's Store is a two story brick building laid in Common bond. It is three byas long by two deep. In each gable wall is an inside end chimney. This building has a gable roof covered with slate. On the facade is a one story porch of early 20th century construction. There is a central entrance with sidelights. The window sash is 6/6 throughout. The store has a stone foundation with cellar. On the rear is a shed addition of frame construction. The interior was not investigated.
