DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The original Blue Ball Tavern is an odd-shaped house due to various additions. First the entire structure is covered with stucco. The building is part brick and part stone. The original portion is in the center on a north-south axis. The roof is gable with a large fireplace in the western wall. This section is roughly three bays by three and two stories in height. The original entrance was in the south west end of the west wall. The roof is wood shingle. On the east and west walls two-story additions have been built. A one-story porch extends the entire length of the west and south walls and appears to be 20th century. The roof on the western addition has a double gable construction.

Unfortunately, the interior was not able to be viewed.
