DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The White Oak School is a frame structure mentioned in deed in 1853. It was a one room school at the time of its construction. Between 1924 and 1970 the schoolhouse was converted into a dwelling. The building is approximately three bays long and two deep, and is one and a half storys in height. The exterior of the building has been stuccoed. The house has a gable roof with two gable roofed doremers facing west. The facade has a central entrance. Much of the window sash is 6/6 vut not original. In the north gable wall is a stone chimney.
