DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Kirk-Wilson Farmhouse was built in 1797 as the date stone in the facade indicates. The house is five bays long by two deep. The eastern most four bays are built of stone with a stucco coating. There is an inside end chimney in each stone wall of this section. There are two entrances on the facade. The window sash is 6/6 throughout. The roof is covered with galvanized sheet metal but originally was wood shingle. There is also a simple box cornice. The two entrances have a one-story porch over them. Attached to the western end of the stone section is a small frame addition.

There are two small outbuildings one of which is a carriage shed. Also there is a medium-size barn. All of these structures are of mortice and tenon construction with board-and-batten siding.
