STATEMENT OF SIGNIFICANCE

The Fell Road Mill site is where a number of early mills once operated. The earliest was probably in working order soon after settlement in 1701-2. If precisely located the site could be of archeological importance. It was within the Penn grant known as the "Mottingham Lots" and on the lot which was owned by James Brown.
