**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Hilaman Greek Revival House is a two and a half story house with eyebrow windows in the attic story. In each gable end is a pair of chimneys. The building measures four bays long by two bays deep with a gable roof. The facade has two front entrances, sheltered by a one-story Victorian style porch, suggesting that the house served as a duplex. The brick work is predominantly common bond, but the pattern seems to be irregular with scatterings of flemish bond in the first story. Each door has a transom over it. The house has a stone foundation and cellar. The window sash on the first two floors is 6/6 while the third floor is 3/3. The rear of the house has a one story frame shed addition. The roof is covered with wooden shingles.
