DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Greeger Farmhouse is a two storey with attic frame structure. It is four bays long by three deep and has a stone foundation with cellar. The house has a gable roof which is covered with asphalt shingles. The exterior surface of the house has been altered from a wooden siding to new aluminum siding. The facade has a central entrance which at an earlier time was protected by a one storey porch that ran the entire length of the house. Today only the fieldstone supports for the porch remain. The windows of this structure have six pane over six sash and there are no shutters on the house. Across the rear wall is a one storey frame addition with a leanto roof. In each gable wall is an inside end chimney constructed of brick.

Behind the house are several early Victorian outbuildings which are all frame and of little distinction. There is also a large barn that has been altered with only the foundation appearing to be original.
