DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Founds House is a two story log structure four bays long by two bays wide. Originally, the house was three bays by two with a single entrance door on the north and south wall. In the eastern end of the hosue was a cooking fireplace. Today, there is an inside end chimney in the east and west gable walls with a gable roof covered with slate shingles. The logs are hidden from view by aluminum siding. The sash is six over six. An addition was made on the east end during the early 1900's when the home was a two family dwelling. Mrs. Hannah Griffith built the kitchen (shed on the rear) some original oak flooring still remains.
