DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Glen Tyan Farmhouse is a two and a half story frame building which is three bays long by two bays deep. The house has a wood shingle roof with a central peaked dormer on the facade. The upper half story windows are gothic sash double windows in the gable ends and single in the dormer. These windows have lowered shutters. On each side of the dormer is a brick chimney. The chimney. The central bay of the second story also has double gothic sash window. The window sash throughout is 6/6 with lowered shutters. The cornice of the roof has brackets which support it. In the central bay the facade is a single entrance with two light transom. This might not be the original entrance for it is slightly off center. The house has a stone foundation and cellar. Built on to the rear of the house is a one story frame Ritchen wing with a brick chimney in the east gable end. The house has weathboard type siding. The facade also has a one story front porch with chamfered supports with peirced brackets.

Behind the house are several frame autbuildings including a barn and carriade shed.
