DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Hensel House is a two and a half story frame dwelling. The house is three bays long by two bays wide with a two story rear wing. The half story is noted by the eyebrow windows with 3/3 sash located over each end bay. There are some other sash in six over six while the uppermost sash in the gable ends is two/four. The house has a stone foundation with cellar. The front porch has been enclosed. The roof has asbestos shingles and the exterior is covered with green tiles (roofing).
