The Dolfinger Creamery is a long brick structure built in the early part of the 20th century. It is one-story in height and is two bays wide by five bays long. In the north gable end is a tall brick chimney. The brick is laid in American bond. On each gable end is a shed extension. One of the original bay doors has been bricked in.
