**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Ayers House is a frame dwelling two storeys in height and is three bays long by two deep with a one storey shed addition on the rear wall. The exterior of the house is covered with shingles laid in stone bond. The gable roof has brick inside end chimneys in each gable wall. The roof has an asphalt shingle covering. The house has a stone foundation with full cellar with an entrance on the east gable wall. The facade of the house has a one bay one storey entrance porch with turned posts. Some of the early 6/6 sash is still present. The house faces north towards the old Nottingham Christien Road. The interior is very plain with built in cupboards in the east end with beaded boards, typical of mid-19th century Cecil county.
