**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Providence Row is composed of eight frame double houses of nearly identical appearance. These structures were built on the west bank of the Little Elk Creek for mill workers just to the north of the old paper mill complex. All of the houses face the stream and are two storeys in height. Each house is four bays by three bays deep with the east gable end of the building serving as the facade. The houses have a two entrances in the center of the facade with a one storey porch with turned posts and brackets or a hood with brackets protecting the entrances. In each gable end of these structures is a brick inside end chimney some of which have been stuccoed. The houses originally had wooden siding but for the most part have asphalt shingles on their exterior surfaces. All of the mill houses have fieldstone foundations. The window sash has been changed in some of the homes but several have 6/6 sash. During the past few years two of the houses have been damaged by fire.
