DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Rock View Tenant House is a two-story frame house built in three sections. The house is six bays long by two deep with a gable roof. The southern two bays appear to have been built first on a stone foundation. The northern four bays appear to have been added. The house has two front entrances with a one-story porch over the center four bays. In each gable end is an inside end chimney. Attached to the rear of this building is a lean-to (one story) addition. The roof is covered with asphalt shingles and has a sparse box cornice. Although some of the windows have modern sash there are several that have 6/6 sash.
