The St. John's Tenant House is a frame building three bays long by two deep. It is two stories in height with attic. In each gable is a brick inside end chimney. The exterior of this structure is covered with asphalt shingles. The facade has a central entrance with transom. The gable roof has a box cornice with returns. Also on the facade is a one-story porch. The sill rests on a stone foundation. The window sash is 6/6. Built to the rear wall is a one-story shed addition.
