DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The providence Gothic House is a large frame structure two stories in height. It is three full bays across by two deep. This house is a double dwelling and seems to have suffered additions. The exterior is covered with multi-colored shingles. The gable roof has a pedimented gable in the center of it, and two brick chimneys, one in the west gable and one in the interior chimney. The facade of the house has a one story porch with a small pediment gable in the center with the date 1905 painted on the face of the gable. The porch roof has turned wooden posts with curved brackets supporting it. The railing balusters are also turned. The porch has two sets of steps, one for each side of the house. The entrances have two light transoms over them. All of the window frames have caps and 2/2 sash. On the east gable is a two story bay window, while the west gable has a two story shed roofed addition.

The house might have been built earlier than 1905 with major renovations in that year. Such as pedimented gable porch and bay window. The removal of these elements would possibly create a date of 1850 or 60.
