DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Reservoir Victorian House is a frame dwelling two stories in height with an attic. The house is three bays long by two deep. In the south gable is a brick inside end chimney. The central bay of the facade has a door on the first floor and a peaked dormer in the attic story. The frame for the dormer window has a segmental pediment. The window sash is 2/2 throughout. The roof is covered with asbestos shingles while the exterior of the building is sheathed with shingle siding. Across the front of the house is a one-story porch that could have been original, but appears to be a 20th century replacement.

STATEMENT OF SIGNIFICANCE

This structure is one of several in the area which were tied into the nearby mill. These structures served as residences to the mill workers and officials of the company. This particular structure could have served a dual purpose, one a house and the second a lodging for someone who would be near the reservoir and be able to adjust its flow.
