**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Ramos Greek Revival House is a large frame structure two-and-a-half stories in height four bays long by two deep. In the half story of the facade is a row of eyebrow windows with 3/3 sash. In each gable end is an inside end chimney. The exterior has clapboard siding. The roof is almost flat but has a slight hip. The window sash on the first two stories is 6/6 with paneled shutters on the first and louvered on the second.

To the rear of this main section is a long five-bay by two, two-story structure, in bad condition. The roof is flat, but could have been gable originally.
