DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a two and 1/2 story dwelling made of brick with a stucco covering. At each gable end is an inside end chimney. The house is 4 bays by 2 bays wide. The window sash is 6 over 6. Under the eaves is a brick cornice. This house is used as an apartment building and has two entrances. It seems that it has always had two front doors. Due to the early industrial significance of the North East, this might have been used as a mill workers' house. On the facade is a one story front porch which runs the entire length of the facade.
