Section 7.1

This House Ruin is located in Cecil County, within the Fair Hill N.R.M.A., and off of Appleton Road.

The Ruin is two and one-half stories tall, constructed entirely of fieldstone, and missing the roof. The fieldstone was uncut, had no courses, and originally was covered with whitewashed stucco. The house is "L"-shaped and roughly seven-bays long by two-bays wide. Since the roof has collapsed much of the woodwork has deteriorated, except for sections of the window trim.

In addition a one-story, wood frame, shotgun style house is located next to the fieldstone house. It has a concrete block foundation, wood clapboard siding, and a sheet metal roof. All windows and doors have been removed from the structure.

These houses are in poor condition, with vegetation overtaking much of the structures.

The house ruins are significant for their representation of architectural styles.

The fieldstone constructed house ruin is distinctive for the size of the structure, as one of the largest fieldstone constructed houses in the region. It appears to date from the early part of the Nineteenth century.

The shotgun style house ruin is unusual in this region, since most houses are farmhouses. It appears to date from the early to mid Twentieth century.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Appleton Road Stone and Log House is an old structure built in three sections. The original house is today a small log rear wing. This building is two bays long by one deep and one and a half stories in height. It is built of logs laid in saddle notch style with the ends neatly dove tailed. In the north gable wall is a large stone and -brick chimney crudely built. The logs were covered both inside and out by lath and plaster. The structure had a gable roof with pinned rafters covered with wooden shingles. A small break neck stair led to the upstairs. This section served as a kitchen in later years.

The main section of the house is composed of two parts. The earlier of these two is directly in front of the log section. It is built of fieldstone and is two stories in height with a stucco covering. This part is three bays long by two deep with an inside end chimney in the west gable. The facade has a side entrance with a stair to the second floor. This entrance had a three light transom over it. Evidence of chairrail in the main room exists in fragments for the house has been vandalized (measured drawing of chairrail has been mde). Beneath this section is a cellar that has a small cooling pantry with an arched brick roof.

To the east of this stone section is another stone part that is four bays across by two deep with an inside end chimney in the east gable wall. It is constructed of the same type of stone used to build the Mitchel House and Little Elk Creek Farm. It still has portions of its roof which is gable and covered with wooden shingles.


