DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Glen Farms 1802 house is a stone dwelling built on the side of a hill overlooking the Christiania Creek. This structure is two stories in height and is bays long by bays deep. The house is protected by a gable roof that has new asphalt shingles that replaced a deteriorated wood shingle roof. The roof has a plain box cornice. In the center of the rear or south wall is a huge stone chimney which is quite rare for Cecil County. The exterior surfaces have been coated with stucco and white paint.

The facade has two entrances each with a six panel door with four light transom above. The door frames are of mortice and tenor construction. The window sash on the first story has a 6/9 sash and the second floor sash consists of six lights over six. Between stories on the facade is a small stone watershed, very primitive, that could indicate the presence of a pent roof in earlier times. A few porch supports from a one story porch built of stone are located across the facade. The mortar joints of the stonework are raised indicating an 18th century influence.

The house has a full cellar with a stone fireplace support. Also massive frame work is visible for the support of the upper floor structure. The interior has two back to back fireplaces on the first floor, and a corner fireplace on the second floor. A breakneck stair connects floors. A small chimney breast composed of dog eared architecture was found in the basement.

Below the house are the foundations of a barn and a mill.
