**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Thankless Lane Frame House is located on the north east corner of the junction of Thankless Lane with Route 273. It is two stories in height with an inside end chimney built of brick in the west gable. The clapboard siding has been covered with aluminum siding. The house is three bays long by approximately 1½ deep with a two story two bay by one rear wing. The roof is very steep and has a slate roof. The front of the house has a central entrance. The windows have 6/6 sash throughout. The house has a stone foundation.

Across the road is a bank barn. The frame work is covered with aluminum siding and sits on an ancient looking foundation of stone.
