DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Seven Stars Tavern is supposed to be over two hundred years old although this has not been verified. The original road ran fifty yards north of the tavern so that the current facade was once the rear part of the structure. During the past fifty years a bad fire damaged much of the building and when the roof was rebuilt the gable design was replaced by a gambrel one. The building is two stories in height and is five bays long by two deep. The walls are built of field stone and are over two feet thick. These walls are covered with stucco. In each gable end is a brick chimney and it is possible that there was another chimney. According to several sources the tavern had twelve fireplaces.

The interior also has been altered, but an early stairway with turned walnut balusters is still supposed to exist. The flooring was the common random width pine and fragments could possibly still be found.
