DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Yale Farm consists of a farm house built in the early 1800's and a frame barn of brick. It is two stories in height and is three bays long by two deep. The house has a central entrance. Across the facade is a single story enclosed porch. The house has a gable roof with an inside end chimney in the west and east gable. Beneath the eaves is a brick cornice that is stepped from the facade wall to the edge of the roof. To the rear of the house is a two story rear wing also built of brick with an inside end chimney.

The barn is located across the road from the house and sits on a stone foundation. It is built of timbers that have been morticed and tenoned together. The barn has a gable roof and board and batten siding.

STATEMENT OF SIGNIFICANCE

This farm is one of the earliest in the area, being one of Nottingham Lots. Early deeds indicate that the Oldham family were early settlers here. The original buildings are gone, but the land itself is still productive. The farmhouse has been altered on the interior to adapt to 20th century living. The exterior still resembles its early appearance.
